# LCAP History

- Prior to 2008 there was base funding and categorical funding
  - Based on avg. attendance
  - Over 50 state & federal pots of money
  - A maze of compliance and reporting

- 2008-2009
  - School budgets crashed
  - Most Categorical funding restrictions were removed and schools were able to use most monies to keep schools running

### Local Control Funding Formula (LCFF) - 2013

- 1. Base Funding (Based on ADA)
- 2. Categoricals (10 areas)

Basic Services, Implementation of Standards, Parent Involvement, Student Achievement, Student Engagement, School Climate, Course Access, Student Outcomes, Expelled Youth, Foster Youth.

- 3. Supplemental and Concentration (S&C money)
  - a. Supplemental monies to provide support for instructional activities and services for the at risk students
    - i. English Learners, Socioeconomically Disadvantaged (Eligible for free & reduced meal program), and Foster youth

# Local Control Funding Formula (LCFF)

- Provides more flexibility and local control in decisions regarding student achievement.
- Involves parents, students, and teachers in decisions about academic programs and expenditures.
- Includes additional funding for at-risk/high need students
  - Socioeconomically Disadvantaged, English Learners, Foster
  - This is referred to as Supplemental & Concentration money
- Requires districts to develop a three-year plan for achieving specific student outcomes, adjusted yearly.

# LCAP Goals, Actions, & Expenditures

- Districts develop <u>GOALS</u> for student outcomes to support the eight state priorities and the board's goals.
- District must develop **ACTIONS and SERVICES** to meet each goal and assign funding.
- Districts must also develop <u>ADDITIONAL ACTIONS</u> to support high need students in meeting goals using S&C funding.
- Districts must seek stakeholder input during development of the plan each year and report out progress as well.

## Previous 2017-2020 LCAP Goals

1. All students will achieve 21st Century Skills and be prepared to successfully transition to a high school college and career readiness pathway.

2. Manzanita Elementary will engage families in the school community to seek input in decision making and increase attendance at school functions.

3. We will ensure all students, staff and community will have access to a safe and caring environment with clean, well maintained facilities, standards-aligned instructional materials and highly qualified staff.

### Data Builds LCAP Goals and Measures Progress Different metrics or measures are used such as:

- Attendance rates
- Drop-out rates
- Language proficiency
- Facility status
- Test scores
- Suspension rates

California's accountability system for continuous improvement is called the California Dashboard

# Stakeholder Input & Role

- **Parent and Student Surveys** indicate areas of strength and areas for growth related to the eight state priorities
- **Community Forums/LCAP Advisory Committee** offers stakeholders an opportunity to give input on goals and actions for student achievement
- Online LCAP Feedback portal is open on the district website for stakeholders to provide feedback and ask questions
- Advisory Groups (e.g. School Site Council) provide input on developing goals and actions during regularly held meetings






#### State Indicators

- 5 local indicators
- Districts populate them with analysis of progress from local data
- Qualitative + quantitative data

3 Performance categories: Met Not Met Not Met for 2+ years
