MESD has implemented multiple strategies for students, families, community members, classified and certificated staff as well as the governing board to provide input in developing the LCAP, LCP, SPSA, Expanded Learning Opportunities Grant, and ESSER Funding. Even in the midst of the global Pandemic and school closures due to COVID 19, MESD has made robust efforts to solicit input from all stakeholder groups. During the Spring of 20-21 a survey was sent to all stakeholders including parents, school staff, and students to solicit input on the use of ESSER funds as well as the LCAP. Links to the survey were emailed, posted on our websites, and were sent to physical addresses with the survey link information.

MESD also held school Site Council meetings on 11/12/20, 1/21/21, 5/6/21, 5/20/21. During the 5/6/21 and 5/20/21 meetings, ESSER Funding was discussed. The Site Council/Parent Advisory Committee is made up of 10 stakeholders including 5 parents, 3 teachers, classified staff, and the principal.

MESD also had an LCAP Advisory Committee Meeting on 4/22/21, 5/6/21,5/20/21,6/2/21in which ESSER Funding was also discussed during meetings in May and June.

MESD Governing Board Dates: August 12,2020, September 9,2020, October 14, 2020, November 12,2020, December 9,2020, January 20,2021, February 10,2021, March 10,2021, April 14,2021, May 12,2021, June 2,2021, June 16,2021. ESSER funding was discussed during the April, May, and June school board meetings. Additional discussions on ESSER Funds will take place during the Fall 21 board meetings in August, September, and October.

MESD ELAC Advisory Committee was held on May 5, 2021, in which ESSER Funding was discussed.  
SELPA May, 26, 2021.

In the Spring of 2021, a statewide survey was developed by the California Department of Education for Migrant Education and this information was considered in the development of our plan

#### A description of how the development of the plan was influenced by community input.

Parents, community members, students, and all school staff provided valuable feedback, that included how to have a greater focus on academics and social-emotional supports to students.

Parents/ Community Members- Parents and community members are requesting that Manzanita School will implement interventions, but also there was a strong emphasis on enrichments for students in academics and exploratories for middle school students. Additionally, parents are seeking additional staff training and implementation of social-emotional supports and counseling.

Students- Students have responded that they feel safe at school. Students have expressed a need for more social-emotional support. Middle school students are requesting more class offerings.

Teachers/ Local Bargaining Units/ School Personnel- Faculty and staff see the need for implementing academic interventions in reading, writing, and math in the school day and professional development in PLC and social emotional learning.

Admin/ Principals- The school administrator is planning on fully engaging staff in professional development focused on high impact teaching strategies, to include engagement norms, PLC, PBIS, and social-emotional tools for students and staff.

SELPA- Continue providing services for all students with disabilities and ensure access to curriculum and grade level standards.

ELAC- Parents wanted to ensure that communication was translated for them.

# ESSER III Expenditure Plan Instructions

## Introduction

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
